221A's vision for the 1265 Howe Street Artist Studios is to support the re-emergence of material culture in the downtown core with a focus on artists who have traditionally been disadvantaged from access to public resources. While 221A is alert and sensitive to the issue of fair and equitable treatment for all, applications are encouraged from members of the following groups that have traditionally been disadvantaged in access to resources: artists of Musquam, Squamish and/or Tsleil-Waututh ancestory, artists of Indigenous ancestry, artists living with disabilities, racialized artists, and artists who identify as women, queer, trans and/or non-binary persons.

Assessment Committee

Applications will be reviewed by a five-person Assessment Committee comprised of recognized artists, designers, cultural workers or curators as well as the inclusion of one of 221A's existing subtenants. Assessment Committee members will be selected by 221A for each assessment intake. The selection of committee members will prioritize people living with disabilities; racialized people; people of Musqueam, Squamish and Tsleil-Waututh descent; people of indigenous descent; and women, queer, trans and non-binary people.

Assessment Criteria

Applications will be assessed based on the following criteria.

- Vision demonstration of alignment with 221A's vision for the 1265 Howe Street Studios.
- Artistic Quality demonstration of artistic achievement.
- Artistic Advancement demonstration of the benefits the 1265 Howe St studio will have on the advancement of the artist's material practice and overall career.
- Impact in the Field and Community– articulation of potential benefits of a studio on the artist's engagement with and impact on both the contemporary art sector and broader community, e.g. fostering connection within the artistic community, nurturing of other artists, advancing equity or improving arts access for new and underrepresented communities.
